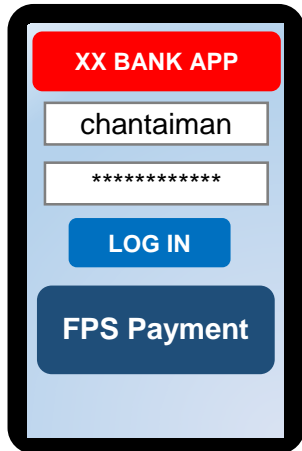
4 You can pay contributions in different ways, including:

- ii. **Online payment or cheque deposit machine of Bank of China (Hong Kong)**, and other e-payment methods: Please refer to the payment method leaflet or <https://www.chinalife.com.hk/products/mpf> for more details. (Diversified services → Payment methods)
- iii. **Cheque:** Please send us a crossed cheque made payable to “**CHINA LIFE MPF MASTER TRUST SCHEME**”, and mark down your name, scheme number, contribution period and contact number at the back of the cheque.

- Before making payment, please check :
 - i. **The payment limit pre-set** at your bank or e-wallet, please contact the relevant service provider for details.
 - ii. Your bank or e-wallet **balance**

6 Open your bank or e-wallet mobile app and select the FPS function (User authentication required)



7 Please select the beneficiary bank (**014 – Bank of China (Hong Kong) Limited**) on the payment page and input the China Life MPF bank account number (**676-0-018888-0**), account holder's name (**China Life MPF Master Trust Scheme**) and contribution amount. You may also enter your scheme number and contribution period in "Message to payee", and press "Confirm" to submit payment.
